Please fill in the information in block letters in legible handwriting or typing in English or Russian/Belarusian.

Answers to the questions should be complete and logically consistent and should indicate the real purpose of the visit.

If a question does not apply, please write "N/A", incomplete forms will be returned to the applicants unprocessed.

The application form should be signed by the applicant **personally**: failure to observe this requirement may result in refusal of the application. The visa application form for a minor should be signed by their legal representative.

Question № 7 (second paragraph). If you changed your citizenship(s), please specify citizenship(s) you held previously and date(s) of acquiring a new citizenship.

Citizens of the former Soviet Union should provide one of the following documents in <u>order to</u> <u>confirm the absence of citizenship of the Republic of Belarus</u>:

- a document certifying the loss of citizenship of the Republic of Belarus or other post-Soviet republics
- a document granting British citizenship (Certificate of Naturalisation)

To prove the citizenship of minors whose parents are from the former Soviet Union, the following documents should be provided:

- Birth Certificate of the minor
- copies of the parents' passports
- one of the documents confirming the loss of the previous nationality of both parents: a document certifying the loss of citizenship of the Republic of Belarus or other post-Soviet republics, or a copy of the old Soviet passport and a document granting British citizenship (Certificate of Naturalisation)
- Question № 15. If you do not have a job, please specify your occupation (e.g. student, housewife, unemployed, etc.). Individual entrepreneurs should specify the type of business activity and business address.
- **Question № 19.** Please indicate the dates of your trip to Belarus, and duration of stay (total number of days), but **not more than 90 days a year**.
- **Question № 20.** Please specify the name of the host person or company (even if the invitation is not required and the period of the intended stay in Belarus is **less than 30 days**).

- **Question № 30.** If you are applying for an entry visa, please specify the departure and destination points of the trip. If you are applying for a transit visa, please specify the departure point, the destination point and the border crossing points.
- Question № 32. Please write that the medical insurance will be purchased at the border on arrival in Belarus.
- **Question № 33.** Please indicate your marital status.
